What is the purpose of the foundation?

The McKellop family started The McKellop Charitable Foundation to provide financial assistance to those in need in our community and in immediate response to those impacted by the devastation of Hurricane Harvey. The McKellop Charitable Foundation provides grants to individuals and families in need, as well as qualified 501(c)(3) Charitable Organizations. The needs of those in the local community will be prioritized.

What type of assistance will be given?

Cash grants may be awarded to any eligible person that can demonstrate preconditioned requirements and need. The grants awarded are intended to provide financial assistance and relief to the effected persons.

What are the Eligibility Requirements?

Financial need must be demonstrated by meeting one of the following criteria:

- Suffered financial loss of possessions/home
- Displaced from home
- Incurred financial hardship

Eligibility criteria will provide a fair and equitable distribution of funds to victims of disasters. Priority will go to those who require the most help. Each case will be assessed on its merits so that any special needs can be considered. The recipient's eligibility is based solely on the facts submitted in the Grant Application. Grants will be awarded based on applicant need and relative to the asset base of The McKellop Charitable Foundation.

All applications must be submitted in writing and delivered to Christel Mark in person, by mail, or by email.
